To help stop the spread of COVID-19, the La Crosse County Clerk and La Crosse County Municipal Clerks are encouraging all voters to please vote by absentee mail.

<u>In light of misinformation being reported earlier this week, voters are still able to request</u> <u>absentee ballots by mail.</u> They may do so so until Thursday, April 2nd at 5pm. We ask that you do not wait that long as the mail does take time and your ballot MUST be returned to the clerk no later than 8pm on election day. We ask that you request your absentee ballot by mail now!

In person absentee voting does start on March 23rd for most municipalities in La Crosse County based upon hours set for absentee voting by the clerk. We are trying to avoid as much in person contact and abide by the 6-foot social distancing guidelines. This guidline is hard to maintain with in person absentee voting and on election day.

Ballots by mail can be requested at myvote.wi.gov

As long as you are registered to vote, you can request it online. Our hope is to limit most in person absentee voting to just those voters who need to register to vote.

We are in unprecedented times right now and we cannot predict what the future may hold in the next week or two. To prevent any voter from not being able to cast their ballot, we cannot encourage you enough to request your ballot by mail now.

Many voters are new to absentee voting and we want to remind voters to make sure you follow the instructions that are included with every absentee ballot in order to properly mark their ballot. Voters should also make sure their absentee certificate envelope is signed by the them AND contain a signature AND address of a witness. This is extremely important to make sure their ballot is counted.

Attached is a list municipal clerk's contact information and updated absentee voting hours. Please don't hesitate to contact me with any questions or the municipal clerks.

Our goal is to make sure every voter has an opportunity to cast a ballot and to make sure that ballot is counted while keeping EVERYONE as safe as we can.

Hand sanitizer, pens and gloves will be provided to clerks for voting to keep the voters and poll workers as safe as possible.
