

TOWN OF GREENFIELD BOARD MEETING ~ Wednesday, May 13, 2020

Meeting was called to order around 7:05 PM, clerk Stacy Burns hosted Zoom meeting, she was at N1800 Town Hall Road, La Crosse, WI. Others were at their homes and present via computer. Chair Jacobs began with the Pledge of Allegiance.

Minutes from the April 8, 2020 Town Board meeting were read by Clerk Burns. After clarifying a portion in resolution 2020-3 to read that, residents will not be charged for First Responder Calls, instead of saying ambulance calls, there was a motion to approve by Supervisor Neubauer, 2nd by Chair Jacobs, all approved 3-0.

Treasurer Report was read by Treasurer Leuck. Motion to accept as read after adding new loan for \$122,364.00 for the tractor purchase was made by Supervisor Timm, 2nd by Supervisor Neubauer, all approved, 3-0.

Road report: Chair Jacobs has a list of roads that need the most attention, he will share it with the board and draw up a list that will be put out for bids.

Shelby Fire Department Agreement was looked at, highlighting the cost of \$48,000 per year plus the 2% dues received by the town that is allocated for Shelby. Motion made by Supervisor Neubauer to approve the agreement as of April 1, 2020, 2nd by Supervisor Timm, all approved, 3-0.

Sanitary District – motion made by Supervisor Neubauer to approve Barry Nelson as new board member for the St. Joseph Sanitary District, 2nd by Supervisor Timm, all approved, 3-0.

Mobile home license renewals. There was a concern about one of the homes and Chair Jacobs will look into having it cleaned up. Motion made by Chair Jacobs to renewal all 3 licenses after application and payment is received, 2nd by Supervisor Timm, all approved, 3-0.

The annual meeting will be held on Tuesday, May 26, 2020 at 7:00 PM. Hopefully this will be an in-person meeting, ZOOM video and conference call will also be an option.

Board of Review will be May 14, 2020 from 5 -7 PM

Citizen Concerns: There will be a blood drive at the town hall on June 8, 2020, please consider giving blood as there is a great need for it right now. A comment hoping that all future meetings continue to have a video / phone conference option was given and will be considered.
