Election News

The General Election this Fall is **Tuesday**, **November 3, 2020**. Polls are open at the Greenfield Town Hall, N1800 Town Hall Road, La Crosse, WI 54601 from 7:00 AM until 8:00 PM

If you haven't registered, the deadline for online or by mail was Oct. 14th. You may still register in the clerk's office before 5:00 PM on Oct. 30th OR on election day. If your valid driver's license does not show the address where you live, you must provide proof of residence for 28 days.

<u>MyVote.WI.gov</u> is a great website that will answer many questions. You may also request an absentee ballot through MyVote.WI.gov.

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may submit a request to vote an absentee ballot to their municipal clerk. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day and who has lived in this township for at least 28 days before the election. The elector must also be registered in order to receive an absentee ballot. Proof of identification must be provided before an absentee ballot may be issued.

The deadline for making application to receive an absentee by mail is: 5:00 pm on Thursday, October 29, 2020.

Voting an absentee ballot in person

You may also request and vote an absentee ballot in the clerk's office (N1800 Town Hall Road) during the days and hours specified for casting an absentee ballot in person.

If you cannot make any of these times, you may make an appointment by calling Stacy at 608-769-8828

No in-person absentee voting may occur on the day before the election.

REFERENDUM

On the Town of Greenfield Ballot this November is a Referendum asking the electors a yes or no question. "Shall the person holding the office of town clerk and town treasurer; or combined office of town clerk and town treasurer, in the Town of Greenfield, La Crosse County, be appointed by the Town Board?"

What does this referendum mean? Why do towns switch to having an appointed clerk or treasurer?

The positives or negatives often depend on one's perspective. But some of the key differences are as follows: Appointed clerks and treasurers: 1. Do not have to be town residents. 2. Have their qualifications, job descriptions, and wages/benefits set by the town board as they are essentially town employees hired by the board. 3. Cannot be removed by the board during their term of office, unless there is "cause" for removal (misconduct in office or neglect of duties). The board can simply choose not to re-appoint an official at the end of his or her term without having to establish cause. 4. Can be appointed for a term not to exceed 3 years at one time. Can be appointed for a shorter term such as six months or one year or whatever the board deems appropriate.

Elected clerks and treasurers: 1. Do have to be town residents. 2. Are answerable to the electorate and cannot be required by the board to hold specific qualifications or obtain training (unless required by state law-such as election training for clerks). 3. Can be recalled from office like other elected officials, but cannot be removed from office by a board vote. 4. Are elected for two-year terms at the spring election in odd-numbered years.

PROPERTY TAXES

Be aware that there may be changes regarding the payment of your taxes. Due to Covid19, we may ask that you mail in your payments OR put them in the town drop box located by the front door of the Town Hall, N1800 Town Hall Road, (by the water tower).

There will be limited face to face opportunities to pay your taxes.



Please watch for the cover letter that will arrive with your tax bill in early December.

Assessments to be updated to 100% market value in Spring of 2021

Associated Appraisal Consultants, Inc. will begin a community wide property revaluation in the Town of Greenfield in the spring of 2021. The revaluation is a complete and thorough review of assessments to ensure that property is assessed at market value. Market value can be defined as the probable price that a careful, willing buyer would pay for a property on the open market without restrictions or special considerations. Properties change, markets change. Buyers and sellers create the market; the assessor's job is to reflect those markets in the assessments. The purpose of the revaluation is not to raise taxes but rather to provide a fair distribution of the property tax burden based on the market value of each property.

So, why is this revaluation being done?

The state of Wisconsin keeps track of the ratio of assessed property and actual sale of property. If we fall outside the percentage of 90%-110%, we become noncompliant with the state.

In 2015, we were 91.22%, which is in range, but in 2016 we were 88.10%; in 2017, 89.07%; 2018, 84.00% and 2019, 84.03%.

We have no choice. This must be done or the state comes in and does it for us, costing us a lot more money. Action needs to be taken this coming spring.

More information will be included with your property tax statements.


St. Joseph Ridge Lions

FIRE PREVENTION WEEK"



Shelby Fire Department, of St. Joseph Ridge, celebrated National Fire Prevention Week, October 4-10, with a visit from the kids at the Toddle Inn Daycare.



Burning permits are required prior to a controlled fire. There

is no fee. Contact any of the 3 board members to get a permit. Please follow the procedure on the forms as they restrict types and size of burns.

You do not need a permit for a campfire. A campfire needs to have a proper ring and needs to be small enough to safely roast a marshmallow over it. If it's too hot for a marshmallow, then your fire is TOO big.

Burn barrels are not allowed in the township.

are busy with grass cutting and trimming along the sides of

the roads. It's best to wait until the grass has stopped growing in late fall. This way it helps for snow not to collect and drift in the long grass. Thanks for watching out for Darrel and Scott.

The Shelby Fire Department has been training hard to serve the community. Currently, we are training in a donated house provided by Don Hess, from Hess Excavating. Trainings include driving, pump operation, flowing water, hose movement inside a structure, forcible entry, incident command, ladder movement to the second floor, and others. This is a great asset that the SFD has been able to use over the summer. Our intention is to provide members with live fire training evolution moving forward.

The SFD assisted the Greenfield Lions Club with Sleep in Heavenly Peace project where beds are built for children that do not have a bed to sleep in. We were able to meet our goal of building 60 beds in one morning. As their saying goes "no child sleeps on the floor in our town." This is such a great organization and it was extremely fun for us to help.

We are finishing up our first ever camper raffle fund raiser. If you haven't gotten tickets yet it may be too late! This is a fundraiser the SFD is using to purchase a replacement boat for the fire department. The one we currently have is becoming old and too small for current needs.

October is fire prevention month. Due to the Covid pandemic the SFD is not having open houses as we traditionally do. However, if you are part of an organization that would like a tour, we are doing virtual tours of our station 1 and 2.
