ORDINANCE NO. 9

An ordinance to promote the public health, safety, welfare and convenience of the Town of Greenfield and providing for the disposal of solid waste materials and a penalty for violations thereof.

The Town Board of the Town of Greenfield, La Crosse County, Wisconsin, acting under the powers of a Village Board does ordain as follows:

SECTION 1. State Rules and Regulations Adopted: The provisions adopted by the State of Wisconsin, Department of Natural Resources contained in regulations NR 51.21 are hereby adopted and by reference made a part of this Ordinance as if fully set forth herein. The Town Clerk is hereby directed and required to file, deposit and keep in his office a copy of these regulations, said regulations to be open for public inspection with proper care by any person during the Clerk's office hours, subject to such orders or regulations which said Clerk may prescribe for their preservation.

SECTION 2. <u>DUMP ATTENDANT:</u> All dumps in the Town of Greenfield shall provide a dump attendant to be present to supervise the disposal of all solid waste materials according to the provisions of this Ordinance, during all times when said dumps are open for public use.

SECTION 3. <u>DUMP HOURS</u>: All public dumps within the Town of Greenfield shall be open at such times as is provided by resolution of the Town Board of the Town of Greenfield. Said hours shall be posted at the dump entrance on a sign, said sign also containing the penalty for non-conforming dumping and containing such other pertinent information as the Town Bord of the Town of Greenfield determines.

SECTION 4. <u>DUMP RESTRICTIONS</u>: No person shall be allowed to deposit any car bodies, stoves, refrigerators or similar types of appliances of like size to those enumerated or dead animals of any type within any public dump of the Town of Greenfield.

SECTION 5. PENALTY: Any person who shall violate any section of this Ordinance shall upon conviction thereof, forfeit not less than \$10 nor more than \$100 together with the cost of prosecution thereof and in default of payment of such forfeiture costs of prosecution shall be imprisoned in the County Jail until said forfeiture and costs are paid, but not to exceeding 30 days. A separate offense shall be deemed committed on each day on which a violation of any provision of this Ordinance occurs or continues.

<u>SECTION 6. PERSON DEFINED:</u> the word "person" in this Ordinance shall be deemed to include any natural person as well as any corporation, association or other organization whether incorporated or not.

SECTION 7. SEVERABILITY: Should any section, paragraph, phrase, sentence or clause of this Ordinance be declared invalid or unconstitutional for any reason, the remainder of this Ordinance should not be affected thereby.

<u>SECTION 8. REPEAL:</u> All Ordinances heretofore adopted by the Town of Greenfield in conflict herewith are hereby repealed.

SECTION 9. EFFECTIVE DATE: The Ordinance shall take effect and be in full force immediately after its passage and publication.
