### **Town Board Meeting; July 14, 2025**

**BOARD PRESENT:** Chair Kevin Timm, Supervisors Chad Morris & Daren Schieldt

**STAFF PRESENT:** Clerk Jill Murphy

**Call to Order:** Chair Timm called the meeting to order at 6:30 p.m. Notices were posted.

**Minutes:** Motion made by Morris/Schieldt to approve minutes of the June 9 town board mtg. **Motion** carried. Motion made by Morris/Schieldt to approve minutes of the June 23 special town board mtg. **Motion** carried.

**Treasurer's Report:** Treasurer's June financial report was presented by clerk Murphy. Motion by Morris/Schieldt to approve. **Motion** carried.

**Shelby Fire Dept.:** Schieldt stated fire on Bina Rd. was paged out differently, but address is in fact in Greenfield; was a mutual aid call so all worked out.

**Roads & Equipment:** Chip sealing starting on Tues. 7/15, on rds. off of County N. Will do Bendel Rd. off Ober Rd. at a later date. A patch on Jungen Rd. off Wuensch rd. needs to be due to a culvert washing out after a storm. Valley Wood Springs had trees damaged from one of the storms; town waiting for estimate from tree service to drop remainder of trees/cut up downed trees. Clerk reported she is still working on claim with Xcel Energy on culvert damaged by company. Barry Nelson inquired about the skid steer town purchased; bid 2 different machines from 2 companies. Bought the new, slightly bigger one from Johnson Tractor; excellent price. Machine can be a backup to loader for loading salt/sand if needed.

**\*Citizen Concerns:** Ron Clark on Elizabeth Way, stated there is an erosion problem with culvert under driveway located in the right of way and with the lawn also. Would like to work with the town on the project as would have changes made to driveway at the time, maybe install some type of curb to redirect water. Timm will stop by after meeting to access the situation and see what can be done. Timm stated he was approached by the county facilities manager and was told the county building next to the store is being put up for sale. The town currently rents a couple of bays for storing equipment with Shelby renting the other two. Stated would like for the town to purchase the building. Would need to take out a short-term loan. Would rent bays to Shelby to offset cost of loan interest and utilities. Stated building would be beneficial to the town right now and would be able to recoup costs if needing to sell sometime in the future.

Motion made by Morris/Schieldt to adjourn. **Motion** carried. Adjourned at 6:42 p.m.
