Town Board Meeting; November 10, 2025

BOARD PRESENT: Chair Kevin Timm, Supervisors Chad Morris & Daren Schieldt

STAFF PRESENT: Clerk Jill Murphy & Treasurer Danny Kjos

Call to Order: Chair Timm called the meeting to order at 6:30 p.m. Notices were posted.

Minutes: Motion made by Morris/Schieldt to approve minutes of the October 13 town board mtg. **Motion** carried.

Treasurer's Report: Treasurer's October financial report was presented. Motion by Morris/Schieldt to approve. **Motion** carried.

Shelby Fire Dept: Schieldt stated Chief Holinka is still seeking out 3 more individuals to be stationed at Greenfield. One person has recently been hired for station #2 and 2 people have been hired for station #1.

Randy Erickson N895 Valley View Rd.; variance for front yard septic system *multi- resident: Timm stated resident doesn't have all the paperwork ready and the variance is not needed still spring. Issue is tabled for now.

Approve list of poll workers for the 2026-2027 elections term: Clerk Murphy read the list of names of persons who have volunteered to be poll workers. Motion made by Morris/Schieldt to approve. **Motion** carried.

Update on county building purchase; W2715 State Hwy 33: Timm stated the town is still working with the county on getting a soil test done and has been getting more quotes for a new roof on both the lg. and sm. buildings. Timm stated the purchase of the buildings probably won't probably happen until next year.

Roads & Equipment: Morris stated again that the plow trucks are DOT ready. International truck was outfitted with a new chain in the spreader and new air tanks were added due the corrosion of the old aluminum ones. Both trucks are ready for plowing. Timm stated he and Scott Roesler will drive and review the condition of the rds. and determine what rds. will need rd. work done in 2026.

***Citizen Concerns:** Pat Manthy stated the mowing on Schieche Rd. was done more aggressively; mowed much further beyond the regular boundaries with many trees being taken down and she is worried about how this will affect the spring run-off. Timm did state the new town employee did the mowing and was instructed to take some of the trees down to prevent overgrowth on the rd. causing a liability to the buses. Timm stated that he will inspect the rd. to see what might be needed to avoid any issues that could arise in the spring. Clerk Murphy stated that the budget meeting will take place on Monday, November 17 starting @ 6:30 p.m. and all residents are welcome to attend. Also stated that the January town board meeting will take place on January 6th instead of the 13th due to a board member being unable to be present.

Motion made by Morris/Schieldt to adjourn. **Motion** carried. Adjourned at 6:38 p.m.
