Town Board Meeting; Tuesday, January 6, 2026

BOARD PRESENT: Chair Kevin Timm, Supervisors Chad Morris & Daren Schieldt

STAFF PRESENT: Clerk Jill Murphy & Treasurer Danny Kjos

Call to Order: Chair Timm called the meeting to order at 6:30 p.m. Notices were posted.

Minutes: Motion made by Morris/Schieldt to approve minutes of the December 8 town board mtg. **Motion** carried.

Treasurer's Report: Treasurer's December financial report was presented. Motion by Morris/Schieldt to approve. **Motion** carried. *Now that the town has received the 1st installment of taxes, Timm asked Murphy to make final tractor loan payment to avoid 2 months of interest. **Kjos stated that the owners of the Brookview/Golden Valley Mobile Home courts are 5 months behind on payments.

Shelby Fire Dept: Chief Holinka not in attendance. Schieldt stated the fire dept is starting on the refresher training for EMR & EMT next week and these trainings will go thru February. Still looking for people to join the dept. and be stationed up in St. Joe's. The dept. has been really busy; had 470+ service calls in 2025; increase due to group homes and assisted care facilities. Will get more exact numbers when Chief Holinka is able to attend the meeting. The dept. responded to 4 different fire calls over the weekend, but none were in Greenfield.

Poll worker list for the 2026-2027 election term: Murphy read name to be added to list; Amanda Kastenschmidt. Motion by Timm/Morris to approve. **Motion** carried.

Roads & Equipment: Morris stated there has been no breakdown/repairs of any equipment. Ron and Sandy Clark asked about sweeping up sand on the road; most of the sand lands in their cul-de-sac. The town had a streetsweeper come for the last 3 yrs; this didn't seem to make much of a difference. Timm stated if there are copious amounts of sand this spring the workers can come sweep and haul it away and take back to the salt shed. Bids are in process for summer rd. repairs.

***Citizen Concerns:** John Kammel asked about replacing the parking lot lights; Timm would like to replace with day & night light sensors. Kammel/Timm will get bids for parking lot and building lights as well; as all the lights are inefficient. Timm stated plowing issues that arose have been addressed.

Motion made by Morris/Schieldt to adjourn. **Motion** carried. Adjourned at 6:40 p.m.
